#### **COVID REQUIREMENTS**

We are committed to providing a covid-safe environment and caring for the most vulnerable in the community. The current requirements for all groups using our facilities are:

**EVERYONE:** Face masks are required indoors, as per government regulations. No-one who has cold/flu symptoms or who is required to be isolated may enter the buildings. Please inform the office if anyone has attended the buildings while potentially infectious. Everyone must check-in using the QR code at the door. Please allow for good ventilation during any group meetings.

**ESSENTIAL SUPPORT GROUPS** (such as AA, GA, AlAnon, etc) do not need to check vaccination status of attendees so long as the size of the groups is limited to no more than 1 person per 4 square metres (Blue Room – 12 people; Green Room – 11 people; Back Hall – 20 people; Main Hall – 30 people).

**ALL OTHER REGULAR GROUPS** are restricted to those who are <u>fully</u> <u>vaccinated</u> only. Everyone much check in and have their vaccination status checked by a designated person (the 'Covid Marshall') in each group. **SUNDAY WORSHIP.** Vaccination status does not need to be checked. #### SPIRITUAL AND PRACTICAL

Sometimes people draw distinctions between 'spiritual' and 'practical' activities. At one level the distinction is reasonable; but as we hear in New Testament letters like James, "show me a person with a relationship with the living God and I'll show you a person who brings good and blessing to those around them." (*Paraphrased*)

This year our gospel readings come from Luke's gospel. Luke is very clear about the activity of the Holy Spirit, guiding and empowering Jesus' ministry and prayer, and the very practical direction of God's care for the poor, the hungry, and the weeping.

In Luke's gospel, very early in his ministry Jesus goes to the synagogue in his hometown of Nazareth (Luke 4:1-19). He quotes from Isaiah that "The Spirit of the Lord is upon me... to bring good news to the poor. He has sent me to proclaim release to the captives, recovery of sight to the blind, to let the oppressed go free, to proclaim the year of the Lord's favour." The Holy Spirit is behind this proclamation.

The idea of seeing *this year* as "the year of the Lord's favour" might inspire our thinking for the year ahead. We are longing for the challenges of COVID to recede, and as they do, we can look for the ways in which God is calling us anew.

The "year of the Lord's favour" could also be a reference to the Old Testament ideal of the Year of Jubilee (see Leviticus 25). Every 50<sup>th</sup> year (after 7 lots of 7 years) there was to a Jubilee year, in which there's is be a 'rebalancing' of landholding and freedom, so that all of the community could experience restoration. It could also refer to 'rebalancing' our approach to ministry and mission as we, and the community around us, emerge from lockdowns and deal with other changes that lie ahead.

As we pray that this will be a year of the Lord's favour, we can expect it to bring both opportunities and challenges. We pray for the Spirit's leading and for the practical directions that will bring. May we be inspired by Jesus' spiritual and practical life, and our vision of connecting with younger generations, embracing all people and strengthening community in the grace and love of God.

Dear High Street Friends,

Once more, it is my great pleasure to update you about matters on which your Church Council were focusing in late 2021 and to pre-empt that which we will be considering in early 2022. We can only hope and pray that 2022 will be a much more predictable and less COVID-centred year, but the latest Omicron variant continues to generate much concern.



## Imminent sale of the former Wesley church site (24-26 High Street): outlining the situation

Many of you will recall the merging of the two formerly independent Uniting Church congregations in High Street: St Andrew's and Wesley which began with conversations in 1996. This was a very carefully considered process, with much consultation and planning involved. Allied to this complex and multi-faceted process, which the two congregations instigated, in 2001 there was an approach made by the Brotherhood of St Laurence (BSL) to potentially lease the soon to be vacated Wesley site. Negotiations commenced and Synod legal advice was sought to draw up a suitable lease with the BSL. This lease was ultimately signed in May 2003, with a 30-year maximum time period, and an option for the BSL to potentially purchase the property after 20 years.

Thanks to the careful and meticulous planning and oversight by our indefatigable Treasurer, Keith Holmes, both the major loan taken out to redevelop our current church site, as well as the loan to largely pay for the retiling of our church roof, have been largely paid off from the rental income accrued from the lease of the Wesley site by the BSL since 2003. Keith has also ensured that a small residual has been retained in a Church Maintenance account.

Given the considerable value of the property (over \$3M), Synod determined that it would assume control of any property sale and the distribution of the funds from its sale. This is in keeping with its standard processes. As a congregation, we were not consulted when the decision was made by Synod Property Services to agree to an early request to sell the former Wesley site in late 2021. Rather, we were informed, as a Church Council in a report, on 14 December last year, that

this would occur.



Of equal importance, was the information contained in that official report concerning the proportion of funds which our congregation would potentially receive from the overall sale. Indeed, it is the unanimous view of your Church Council that the formula being proposed is manifestly unjust. To that end, on 20 December last, Church Council held an extraordinary meeting and determined that a detailed letter be written and sent to the Moderator and General Secretary of Synod,

requesting a face-to-face meeting in our church in early 2022. This letter was lodged before Christmas and we are awaiting a response.

Please rest assured that we will continue to actively pursue this matter to hopefully ensure a more favourable financial outcome for our church, which will enable our missional work through redeveloped and renewed rear buildings to become a reality, reflecting the extensive plans drawn up by Murray Burdett several years ago.

## **Joint Nominating Committee**

As you should hopefully be well aware, the congregation previously unanimously endorsed the recommended composition of its representatives on the Joint Nominating Committee: Karin Jooste, Jen Johnson, Ross Huggard, Rowena Quintanilla, Meg Ryan and Tim Lake. This group will oversee the steps associated with the selection of a recommended Minister of the Word to replace Rev David Fotheringham, who will finish his time with us in May this year before moving to his next important role as the incumbent Moderator. Under the chairing of Rev Joy Blamires (Minister: St Mark's, Mornington) several meetings have now been held.

It was most helpful and reassuring to receive over 80 submissions to the Congregational Survey which was conducted in early December. This data has been closely analysed and reflected upon in the process of finalising the Placement Profile.

The final version will be presented to Church Council for its potential endorsement early in 2022. Once approved, this will then be sent to the Presbytery and Synod for approval.

Clearly, this process is a most important one, requiring close adherence to the specified Synod steps. Rest assured that this will be followed rigorously as we all work towards hopefully selecting the most suitable minister to lead our congregation into the future with optimism.

## **Property for Mission process**

We have received information from the Presbytery Property Committee concerning the need to undertake a detailed study of our missional needs with respect to buildings so as to complete a Property for Mission Workbook. We have indicated that we would welcome the support of an appropriately skilled person, as offered, to undertake this important but complex process, hopefully in the first half of 2022. We will update you further once the process has commenced.

## **Replacing our Church Office Administrator**

Following the departure of our former Office Administrator, Jacqui Harris, in November, Church Council sought to review and redevelop the position description for the important support role of Church Office Administrator (formerly known as the Church Office Secretary). The appointed Selection Panel considered the applications and shortlisted applicants, and after interviews in late December, determined that this role would be performed by Esther Galvin. She has commenced in the position and we are confident will bring a warm and caring demeanour, as well as a high level of diverse key administrative skills to this important role.

#### MONASH UNIVERSITY CHAPLAINCY



My fingers are crossed for a smooth start to Semester 1 this year, hopefully without many of the restrictions due to COVID which affected Semester 2 last year!

Of course, back then we were in lockdown, and I was working from home, and again found that it was reasonably quiet in terms of new referrals coming through, as so much of my work is generated from being on campus and having face to face contact with students and staff. I was, however, still able to carry out some good work with students and staff I was already in contact with.

This included:

- Keeping in touch with around 20 students through Facebook and Email, checking in with how they are managing and coping.
- Zoom and phone appointments with a small group of students.
- Human Book Library talking with about 20 Occupational Therapy students.
- Obtaining some Coles vouchers to distribute to students who are struggling financially, in conjunction with the International Students' staff member at Peninsula.
- Organising additional financial assistance for a particular student in very difficult circumstances in liaison with the Student Union.
- Attending campus network meetings and keeping abreast of campus happenings.

I also spent some time making pastoral care phone calls for our church and studying a Clinical Pastoral Education (CPE) course. (CPE provides training in the practice of pastoral care though an experiential education process. It is recognised as a tertiary-level subject within a theology degree.) I really enjoyed this and found it very worthwhile.

Plans have been underway for some time for a more "normal" orientation and Semester 1 and let's hope that these come to fruition given what is currently happening all around us! I'm very much looking forward to connecting with staff and students again, providing all goes well.

### **PASTORAL CARE**

I am so pleased to be offered the opportunity to do some pastoral care work for our church, from February, for one day per week. Brenda Cooper has been in this role and is finishing up her work at the end of January. It will be hard to fill Brenda's shoes, but I'm really looking forward to it, as it's work that I love and am passionate about. I'm also very happy to serve in this church with its wonderful people. 


### Out of the Mouths of Babes - Children write to God.
